# **We need whistleblowers - and a Free Press!**

**Witness K, David McBride and Richard Boyle** are whistleblowers who are being prosecuted for reporting their concerns. These whistleblowers are people of integrity who raised concerns about wrongdoing *within* their organisations before going public regarding the issues.

Witness K had concerns regarding the Australian Government intelligence organization bugging the Timor Leste's government offices during the negotiations over the Timor Sea oil, giving Australia a distinct advantage. This is particularly reprehensible given that Timor Leste is a poor country striving to get on their feet after the years of colonization by Indonesia.

Witness K's lawyer, **Bernard Collaery**, is being prosecuted as a result of just doing his job defending Witness K. This is an outrage and gross abuse of power as are all of these cases.

David McBride raised his concerns about the possible war crimes of Australian soldiers in Afghanistan, and Richard Boyle similarly raised concerns about the harsh processes for collecting what the tax office had assessed as tax debts. Both David and Richard were failed by their organisations, which failed to act effectively to address the concerns.

In Witness K's case, the bugging should not have been ordered in the first place, as it was done to gain economic advantage over a poor neighbour and is morally reprehensible. It had and has nothing to do with national security, but a lot to do with national embarrassment.

**The raids on the ABC** and journalist Annika Smethurst around the Afghanistan files are a dangerous precedent.

All these cases involve information which the public has a right to know. They are unjust and designed to intimidate public servants, other whistleblowers, journalists and the public. This is dangerous in the extreme for our democracy.
